#### **Privacy and Data Policy**

The Oundle Society and The Old Oundelian Club (OO Club) have a coordinated approach to keeping former pupils (known as OOs), parents (current and former), and supporters up to date with news, benefits, events, reunions and other opportunities, as well as fundraising campaigns. ## Legal Basis for processing

Our legal basis for processing personal data when required is as follows:

- Legitimate interest and/or consent

Some processing of data may be carried out to perform a contract with you or it is required by law such as the completion of due diligence or when processing Gift Aid.

## What data do we process

The Oundle Society and The OO Club collects and holds the following data, where possible:

- Names (including former).
- Contact details, including postal address, email address and telephone number.
- Engagement with School, including event attendance.
- Details of Oundle education.
- Details of higher education where applicable.
- Interests and activities both whilst at Oundle and after (such as sports, music etc.).
- Philanthropic and volunteering, including any gifts and services to Oundle.
- Relationships to other Oundle community members.
- Employment and professional activities.

### **How we collect information about you**

The information we collect allows us to provide the best tailored experience for our OOs and supporters.

If you are an Oundle parent your data will be transferred to The Oundle Society when you join. If you are an OO your record is transferred to us once you leave. OOs automatically become members of The OO Club once they leave Oundle.

The Oundle Society and The OO Club also collect information through admissions, event registrations and forms such as our contact details form on the website. We also collect information from conversations within the Oundle community. We also seek to collect data from publicly available sources of information, such as social media, PR announcements and news outlets.

### **How we use this information**

To provide you with information about our work and activities, including sharing e-newsletters, invitations to events and volunteering opportunities.

For administration purposes and record management.

To ask you for your permission to use the story of your experiences at Oundle to help support our work or market the School.

To monitor and improve the services we offer to the Oundle community.

To ask for your support financially.

To transfer to HM Revenue and Customs in respect of any Gift Aid claims.

To help manage our events, this may include sharing your name with external venues for seating plans and other administrative tasks relating to the event.

We may assess your personal information for wealth screening purposes in order to gain a better understanding of how we should engage with you and to tailor our communications with you. We also use this to make informed decisions about our fundraising strategy. It is our intention to ensure that any approaches made to you are respectful and professional and based on evidence suggesting that you might be interested in our work. Wealth screening is carried out by a trusted third party and includes information such as your name, postcode and data on your existing relationship with Oundle.

### **How we keep your data secure – including who has access**

All information is held securely in secure servers, and our network is protected and routinely monitored.

We use a third-party system to store and manage your data. This information is held securely, and we take appropriate measures to ensure that the information provided to us is secure, accurate and up-to-date and kept only as long as it is necessary to do so.

Occasionally information may be disclosed on a considered and confidential basis to Governors and other employees of the Corporation of Oundle School and The OO Club.

Data may also be transmitted to third parties who provide services to The Oundle Society or The OO Club such as mailing houses, they are required to remove all information once their services have been carried out.

The Oundle Society and The OO Club also facilitate communication between former pupils; however, we will never release personal contact details to others without your prior permission to do so.

We will also never sell or share your information with any third parties for their own use, or for them to market to you.

### **How long do we retain your data for**

The Oundle Society and The OO Club considers its relationship with OOs and its supporters to be life-long. Our legal obligations and tax and accounting rules help to determine how long we should retain your information. All information is securely disposed of once it is no longer needed.

### **Your choices and right to be forgotten**

At the end of the day our commitment is to you, but you are in control of your data.

If you have any queries, wish to restrict data processing or sharing, or do not want to be contacted by the Oundle Society at all, please inform us by contacting [oundlesociety@oundleschool.org.uk](mailto:oundlesociety@oundleschool.org.uk).

- You have the right to request a copy of the information we hold about you.
- Right to be forgotten – in certain circumstances you can request the information we hold about you to be removed from our records.
- Right to object – you have the right to object to certain types of data processing, such as types of marketing.

If there are specific publications, communications, or activities from which you wish to unsubscribe, please let us know and your wishes will be recorded and respected.

We keep our privacy and data protection policies under review, and any changes we make will be published on our website and made available via hardcopy on request.
