SCHOOL TRIPS TERMS AND CONDITIONS

Cost of the Trip

The cost quoted is the best possible estimate of the total cost of the trip. It is expected that most trips are completed within budget but if there is a significant shortfall due to unforeseen conditions beyond the School's control (e.g. fuel surcharge, currency fluctuations) the School may request a further payment on the first bill after the trip. If there is a significant surplus parents will be refunded on the next bill.

Withdrawal from the Trip

If I withdraw the named pupil from the trip I understand that I will be liable for a minimum of 25% and up to 100% of the cost of the trip depending on the time of withdrawal and to ensure all costs to the School are covered.

In the event of my child leaving or being required to leave the School before or during the trip, the School will use its best endeavours to mitigate my liability. However, I understand that I will be liable for a minimum of 25% and up to 100% of the cost of the trip depending on the time of my child's leaving School and to ensure all costs to the School are covered. I also understand that I am similarly liable for costs in the event of my child being withdrawn from the trip by the School for disciplinary reasons.

In exceptional and unforeseen circumstances (such as a serious infectious disease developing at the destination) the Head may, at her discretion, decide that it is in the best interests of the pupils for a trip to be cancelled before departure. If so, then the School will use its best endeavours to mitigate costs incurred. However, I understand that I will be liable for the remaining costs of the trip.

Insurance

Declaration

- I consent to my son/daughter taking part in the trip linked to the Consent and Medical Form I have completed and, having read the information sent regarding the trip, agree to his/her participation in any or all of the activities described.
- I understand the costing information and insurance arrangements for the proposed trip.
- My son/daughter is in good health and able to participate in the proposed activities. Should his/her health change significantly between now and the trip, I will inform the School and, if appropriate, withdraw my child from the trip.
- I have noted where and when the pupils are to be returned and I understand that I am responsible for my child getting home safely from that place.
- I have completed the required medical details on the Consent and Medical Form and give permission for proprietary medicines (as indicated) to be administered if deemed necessary.
- I will notify the School of any changes in circumstances that affect his/her participation.
- In the event of an emergency I agree to my child being given any medical, surgical, optical, or dental treatment, including general anesthetic and blood transfusion, as considered necessary by the medical authorities present.
- I will ensure that adequate supplies of medication are provided when appropriate.
- I acknowledge the need for good conduct and responsible behaviour on my child's part.
- I understand that for any insurance claim the School makes on behalf of a pupil, I am liable for the excess charge that the claim may incur.
